the purpose of EG and GIZ's joint project management and implementation. EG and GIZ collect and process your personal data in accordance with Article 6 of the GDPR only if you have given your consent, if collection and processing are necessary for the performance of the contract or pre-contractual measures, if there is a legal obligation to do so, or if this is necessary to safeguard our legitimate interests or those of a third party, provided that these are not outweighed by your interests and fundamental rights and freedoms. This does not affect the lawfulness of any data processing up to the time of revocation.

Who receives your data?

Within Engagement Global and GIZ, your personal data will only be made available to persons and units that need it to fulfil the above-mentioned purpose. For the purpose of acquiring, placing and supervising experts, your data may be passed on to external service providers, consultants/appraisers and GIZ employees in various countries which have strategic or administrative significance for the assignment of an expert. Your data may also be passed on to the Federal Ministry for Economic Cooperation and Development, the Federal Audit Office and the Budget Committee of the German Bundestag for verification purposes.

How long will your data be stored?

We will erase your personal data as soon as it is no longer required for the above purposes and if erasure does not conflict with statutory retention obligations, but no later than at the end of the project in 12/2022.

What are your data protection rights as a data subject?

As a data subject, you have the right to enquire about your personal data, have the data corrected, request that processing be restricted or data to be deleted, and the right to data portability. You also have the right to object to the processing of your data for the purpose of direct marketing at any time without having to provide any reasons or if for personal reasons your legitimate interests outweigh the interests of processing.
